Contract-Oriented Optimal Economic Dispatch of Thermal Generators in a Multi-Area Deregulated Power System

ABSTRACT: Bilateral contract between the Distribution Companies (DISCOs) and Generation Companies (GENCOs), modelled using DISCO Participation Matrix (DPM), has significant impact on the economic scheduling scheme of thermal generators in Multi-Area Power Systems (MAPS). Neglecting the contract while formulating the scheme can results in suboptimal solutions and inefficient utilization of resources. Thus, this paper proposed a DPMconstrained optimal Economic Dispatch (ED) scheme for multi-fuel type thermal generators in MAPS. The ED scheme minimized the fuel cost of the generators of each GENCO subject to the DPM, generation-demand balance, generation limits, and line transmission capacity as constraints. Due to its fast convergence, flexibility and global optimum searching mechanism, Cuckoo Search Algorithm (CSA) is used to solve the ED problem. The developed scheme is implemented on IEEE 39-bus and 52-bus Nigerian Power System (NPS) both partitioned into three CAs with multiple DISCOs and GENCOs. The effectiveness of the scheme is evaluated by simulating the systems in MATLAB environment. The performance of the ED on the IEEE 39-bus is evaluated by comparing it with those obtained using Grey Wolf Optimizer (MOGWO). It is observed that the fuel cost is reduced by 22.34%, from 5.655×10⁶\$/h obtained using the MOGWO to 4.392×10⁶\$/h with the developed CSA-based ED schemes. This signifies a substantial improvement over the MOGWO-based solution. Likewise, the ED scheme's performance on NPS is evaluated by comparing its performance with that obtained using Bat Algorithm (BA). For the 24-hour ED on the NPS, the fuel cost is reduced from 2.467×10^6 h to 1.953×10^6 h, representing 20.85% reduction. These cost reductions emphasize the significance of imposing the DPM constraint as well as the superior optimization capability of the CSA algorithm in generating schedules that minimize fuel costs compared to the MOGWO and BA-based methods.

I. INTRODUCTION

Deregulation of power systems has gained significant momentum worldwide as countries seek to shift away from centrally controlled Vertically Integrated Utility (VIU) power systems. (Ahmed *et al.*, 2022; Athab & Majeed, 2020). This transformation is driven by several primary goals, including the introduction of competition, enhancement of efficiency, and provision of cost-effective electricity to consumers (Anil & Srikanth, 2018). In a deregulated power system, Generation Companies (GENCOs) and Distribution Companies (DISCOs) function as separate entities, operating independently within an open market framework (Sehrawat & Lather, 2019).

The key objective of power system deregulation is to foster competition among market participants, thereby encouraging innovation, cost reduction, and improved service quality (Azizivahed *et al.*, 2020). By dismantling the VIU monopoly structure, deregulation aims to create an environment where multiple GENCOs can generate electricity and compete to sell

it in the market (Basu, 2019). Likewise, DISCOs, also known as retail electricity providers, have the freedom to purchase electricity from various GENCOs, within or outside their Control Area (CA), and sell it to end consumers (Guo *et al.*, 2017; Kumar *et al.*, 2022).

Under a deregulated power system, the trading of electricity takes place in open markets. Market mechanisms, such as power exchanges and bilateral contracts, facilitate the buying and selling of electricity between GENCOs and DISCOs (Chen & Chen, 2021). These market mechanisms introduce flexibility and transparency, allowing market participants to negotiate prices and quantities of electricity based on supply and demand dynamics. Consequently, consumers benefit from a wider choice of electricity providers and competitive pricing (Sehrawat & Lather, 2019; Jian & Zhou-Jing, 2019).

Moreover, deregulation also aims to enhance the overall efficiency of the power system. By introducing competition,

GENCOs are incentivized to optimize their generation strategies and minimize costs to remain competitive in the market (Chen et al., 2023). This drive for efficiency can result in more economical generation practices, improved utilization of resources, and reduced operational expenses (Karri, 2013). Additionally, DISCOs are encouraged to enhance their distribution networks and customer service to attract and retain customers in a competitive market (Almansury & Al-Anbarri, 2023). Furthermore, deregulation seeks to provide costeffective electricity to consumers. Increased competition in the market can lead to competitive pricing among GENCOs, offering consumers the opportunity to select electricity suppliers based on price, quality, and other value-added services. This competition-driven pricing can potentially lower electricity costs for end consumers, fostering affordability and accessibility (Musau et al., 2016; Jadoun et al., 2015)).

In addition, the GENCOs struggles to generate power at the minimum possible costs and transmission losses (Nguyen & Fujita, 2017). As such, optimal scheduling of thermal generators owned operated by the GENCOs is crucial for ensuring the efficient and reliable operation of deregulated Multi-area Power System (MAPS) (Guo et al., 2017). This scheduling process involves determining the appropriate generation levels of thermal units at different time intervals to meet the forecasted load demand while taking into account various operational constraints. By implementing effective scheduling, it is possible to minimize generation costs, maintain a balance between supply and demand, and optimize the utilization of available resources. Various research efforts have addressed ED in MAPS (Kunya et al., 2023). For

instance, Sakthivel & Sathya, (2021) proposed the use of a Fuzzified Squirrel Search Algorithm to solve the Single-Area Multi-Fuel ED (SAMFED) and Multi-Area Multi-Fuel ED (MAMFED) problems. The SAMFED aims to find the optimal generation schedule for a single area, while MAMFED focuses on optimizing power transfers between different areas while considering fuel alternatives and various constraints. In Yu et al., (2023), a novel hierarchical reinforcement learning architecture for solving the multi-area economic dispatch (MAED) problem in a fully off-line optimization manner is presented. The proposed architecture transforms the MAED problem into an augmented sub-MAED problem and utilizes distributed Q-learning and multi-stage decision algorithms to calculate the optimal output power within each area. While in (Sehrawat & Lather, 2019), an intelligent, agent-based approach for ED in a MAPS is proposed by utilizing a multiagent system with a consensus method, eliminating the need for a central controller and reducing computational efforts.

In a similar study (Yin & Sun, 2022), presented the challenges faced by traditional centralized ED optimization methods such as slow calculation speed, privacy concerns, and limited consideration of multiple cost objectives is addressed. Multi-objective grey wolf optimizer (MOGWO) optimizes the sub-problems of each area independently while sharing only limited boundary bus information between areas, enabling overall optimization (Sakthivel & Sathya, 2021; Shao *et al.*, 2023). A distributed models are presented in Yin & Cai, (2024a) and Yin & Cai, (2024b) with hierarchical structure that significantly reduced the computational complexities. Other similar studies reviewed are summarized in Table 1.

Despite the various contributions of these studies, most of the existing scheduling schemes in MAPS overlook the significance of the bilateral contracts between DISCOs and GENCOs and their impact on the schemes. These contracts defined by the DISCO Participation Matrix (DPM) outline the participation factors of each GENCO in each Control Area (CA) and their contractual obligations with each DISCO within or outside the CA. Failure to consider the DPM in the MAED can lead to suboptimal solutions and inefficient resource allocation.

To address this gap, this study developed a DPM-constrained optimal scheduling scheme specifically designed for thermal generators in MAPS. The scheduling scheme takes into account the DPM, capturing the participation factors of each GENCO in each CA and their contractual obligations with DISCOs. By incorporating the DPM into the scheduling process, the scheme seeks to enhance the effectiveness of the optimization process while ensuring compliance with contractual obligations and other constraints. Specifically, the contributions of this study are itemized as

- Incorporating the DISCOs GENCOs bilateral contractual obligations (modelled using DPM) in the formulation of MAMFED problem,
- Application CSA for the solution of MAMFED with distributed architecture,
- Demonstrating the effectiveness of the scheme on both analytical (EEE 39-bus) and real-life (52-bus Nigerian Power System) systems both partitioned into three CAs.

After this introductory section, Section II discusses ED scheme in deregulated power system. The formulation of the proposed distributed MAMFED is presented in Section III,

while section IV discusses the simulation results. The paper is concluded in Section V.

II. ECONOMIC DISPATCH IN A DEREGULATED SYSTEM

Conventionally, ED involves allocating the power generation among various units in a manner that minimizes the overall production costs while satisfying system reliability and operational constraints. While in MAPS, ED is used to coordinate generation schedules and inter-CA energy transactions among nearby CAs while minimizing the overall fuel cost devoid of violating any the constraint. ED can be implemented in either centralized or distributed manner.

A. Centralized and distributed Economic Dispatch model

In the centralized approach, the central dispatch center receives the online information about the generation level of each unit centrally, P_{Gi}^t as shown in Figure 1. Using the information, the dispatch command signals, μ_{G4}^{t+1} are generated at the dispatch center and transmitted to each unit for the next

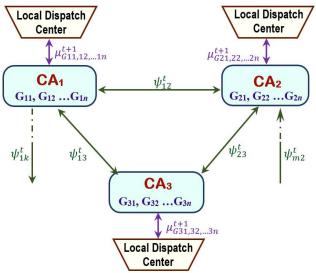


Figure 2 Distributed ED model

However, with the recent exponential growth of PS, the traditional centralized ED programmes suffers numerous setbacks like slow computational speed, communication congestion leading to excessive communication delay, and vulnerability to security attacks. Hence distributed approach is preferred (Yin & Sun, 2022).

In distributed approach, each CA has its local dispatch center and shares the information about the generation level of each unit and other ancillary services with its adjacent CAs, as depicted in Figure 2.

B. DISCOs Participation Matrix (DPM)

The DISCOs-GENCOs bilateral contracts are defined using the DISCOs participation matrix (DPM). The number of DPM rows indicates the number of GENCOs (ψ), while the number of columns denotes the number of DISCOs (ψ) in the network. DPM diagonal elements represent the contractual agreement between GENCOs and DISCOs situated within the same CA. While the off-diagonal elements represent the power contract across different CA as shown in (1).

The elements of DPM known as contract participation factor (cpf), λ_{ij} is a fraction of *i*th DISCO's LM requirement contracted to the *j*th GENCO. It can be deduced that:-

- The block diagonals, λ_{ij} ; $\forall i = j$ correspond to CA local demands.
- Off diagonal blocks λ_{ij}; ∀i ≠ j indicate the demands of the DISCOs in one area to the GENCOs in another area.
- The sum of all element in a column/row in the DPM is unity, as expressed in (2)

• If $\lambda_{ij} = 0$, there is no LM contract between DISCO *i* and GENCO *j*, thus, $0 \le \lambda_{ij} \le 1$,

Therefore, the power generation of each GENCO in *i*th CA based on its contract with the DISCOs can computed based on the DPM as shown in (3) (Lekshmi & Balamuruga, 2017)

III. MAMFED FORMULATION

The objective of the MAMFED is to minimize the total fuel cost of generators, owned and operated by GENCOs in all CAs through the coordinating the generation levels and cross-border energy.

A. Objective function

The objective function of the MAMFED is formulated as min(F), where F is the total cost of fuel of the thermal units in all the CAs, defined as

Where N is the number of CAs in the MAPS (3, in this regard), \mathcal{J} is the number of GENCOs, while F_{ij} and $P_{G_{ij}}$ are the fuel cost and power generation by jth GENCO in ith CA.

In this paper, a quadratic-trigonometric polynomial functions of generated power shown in (5) is used.

Where a_i , b_i , and c_i are the cost coefficient of generators.

B. Constraints

The constraints considered are the GENCO-DISCO bilateral contract defined by the DMP (as formulated in (1) –

(3)), generation-demand balance, and tie-line transmission capacity.

A. Generation-demand balance in MAPS

The generation-demand balance constraint is formulated such that power generation from all the GENCOs, the total demand, and the transmission losses, P_{loss} are equal as shown

Where P_l^{loss} is the transmission loss along the lth tie-line in the system expressed in (7),

The P_i^{tie} defining the aggregate power exchange between DISCOs and GENCOs operating in different CAs, as in (8)

Where contract participation factor, λ defines the fraction of DISCO's LM requirement contracted to the GENCOs in different CAs. The first term of (8) models the contractual agreement between DISCOs in ith CA with GENCOs in ith CA, while the second represent the contract between DISCOs in different CA to the GENCOs in the same ith CA.

B. Generation limits

The output power of each generator is constrained within certain pre-defined lower and upper limits as expressed in (9)

C. Tie-lines transmission capacity

The transmission lines interconnecting the multiple CAs need to be constrained within certain upper limit that should not exceeded due to contract violation and technical considerations. This constraint is expressed in (10):

IV. APPLICATION OF THE CUCKOO SEARCH ALGORITHM

To solve the proposed MAMFED problem, Cuckoo Search Algorithm (CSA) is applied.

A. Concept of CSA

CSA is a powerful meta-heuristic optimization technique inspired by the unique reproductive strategy of cuckoo birds, which lay their eggs in the nests of other birds. Developed by (Yang & Deb, 2009) CSA utilizes a combination of Lévy flight-based random walks and an elitist selection mechanism

to efficiently explore and exploit the solution space. This approach enables CSA to effectively navigate complex optimization landscapes, making it particularly useful for solving nonlinear and constrained optimization problems like the ED.

The algorithm is particularly well-suited for solving the MAMFED problem. The algorithm's ability to avoid local optima ensures high-quality solutions even in the presence of complex constraints such as valve-point effects, prohibited operating zones, and transmission losses. Additionally, CSA exhibits fast convergence due to its efficient exploration strategy, making it computationally effective for large-scale MAPs. Its flexibility and robustness allow it to handle realworld uncertainties, ensuring a reliable and cost-effective power generation schedule while maintaining system stability and efficiency.

B. CSA Implementation for the MAMFED

The CSA is implemented to solve the MAMFED formulated in (4) and (5) subject to the constraints modelled in (6) - (10). Table 2 presents the pseudo code that summarizes the implementation steps.

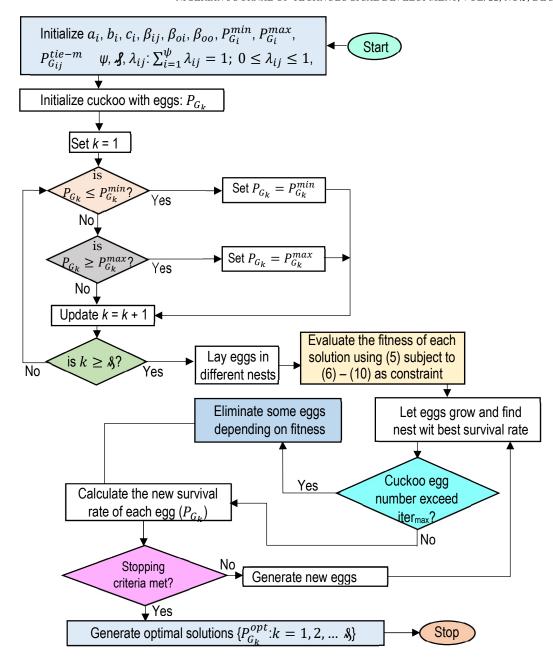


Figure 3 Flowchart of the developed CSA-based ED scheme in MAP

V. RESULTS AND DISCUSSION

To assess the effectiveness of the proposed scheduling scheme, the two systems considered are modelled and simulated in MATLAB. It is implemented on IEEE 39-bus and Nigerian Power System (NPS), both partitioned into three CAs with multiple DISCOs and GENCOs.

D. ED Scheme on IEEE 39-Bus System

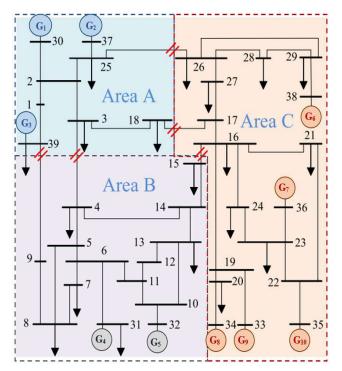


Figure 4 Partitioned IEEE 39-bus System

Figure 4 depicts the partitioned IEEE 39-bus, while Table 3 summarized the composition of the CAs and the location of the GENCOs.

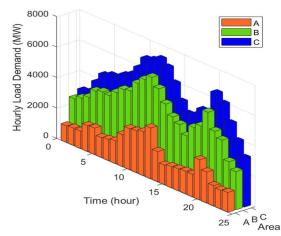


Figure 5 Daily Load demand for IEEE 39-bus system

In this study, the IEEE 39-bus system is loaded with load profile shown in Figure 5. The developed ED scheme is then applied to minimize the fuel cost of the 10 GENCOs subject to the constraints.

The load demand profile has the daily averages of 1775.8MW, 4290.4MW and 5227.5MW for the areas A, B and C respectively, as shown in Table 4. Subsequently, various schemes were used for comparative analysis using the daily fuel cost as the performance metrics.

The Area Participation Factors (APF) are defined to model the contractual agreement between the control areas. In this study, the APFs are chosen arbitrarily as 0.25, 0.30 and 0.45 for area A, B, and C, respectively. They are chosen arbitrarily since they are determined by market forces in real scenario. With these APFs, the GENCOs from the three control areas are expected to meet up with their contract obligations by generating 25%, 30% and 45% of the total demanded power in the entire system respectively. For instance, at 09:00am, the optimal generations are 3250MW, 3900MW and 5850MW from area A, B and C respectively.

From the results, it is found out that the developed CSA-based ED determined the optimal generations by assigning optimal contract participation factor, λ to each GENCOS, as summarized in Table 5. As a hard constraint, all the λ 's in each area added up to the area's APF.

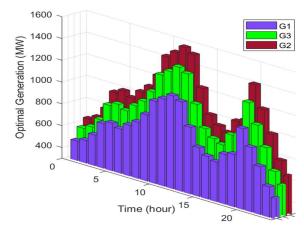


Figure 6 Optimal Participation of area A GENCOs

Figure 6 shows the optimal generation from the GENCOS in area A. It shows how the 25% of the total generation allocated to area A is optimally shared to GENCOs by the developed ED

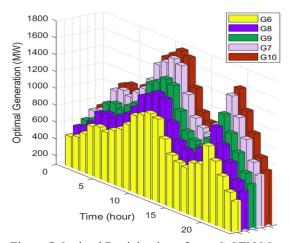


Figure 7 Optimal Participation of area C GENCOs

As summarized in Table 5, the three GENCOS, G_1 , G_2 and G_3 in area A optimally generate power in the ratio of 0.07:0.095:0.085 to meet up with the 25% generation share.

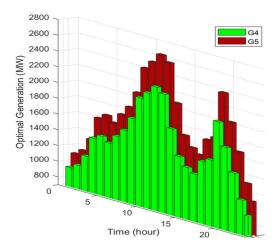


Figure 8 Optimal Participation of area B GENCOs

For instance, at 16:00, the generations from area A are 693.00MW, 940.5MW and 841.5MW from G_1 , G_2 and G_3 respectively, which corresponds to the optimal λ shown in Table 5. Figure 7 and 8 show the optimal participations of GENCOs in areas B and C respectively.

In the same way, the optimal λ of the area C are 0.0675, 0.1035, 0.081, 0.09 and 0.108 for G₆, G₇, G₈, G₉, and G₁₀ respectively, which optimally add to the 45% of the generation share. For instance, at 23:00 hour, 3735MW (representing 45% of the total hourly demand of 8300MW) is obliged to area C

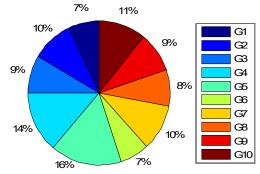


Figure 9 Optimal generation share for IEEE 39-bus system

The developed ED optimally allocated the generation levels as 560.25MW, 859.05, 672.3MW, 747.00 and 896.40 to G_6 , G_7 , G_8 , G_9 , and G_{10} in order to meet up with 3735MW at reduced fuel cost, devoid of violating the rest of the constraints. The overall generation share from all the 10 GENCOS is as shown in Figure 9.

To ascertain the effectiveness of the scheme, the total generation cost is compared other optimal schemes. From the simulations, it is observed that the fuel costs GENCOs in area A, B and C are found to be 1.216×10^6 , 1.326×10^6 and 1.142×10^6 \$/hr, adding up to 3.684×10^6 \$/hr, as summarized in Table 6.

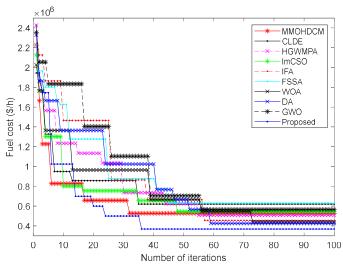


Figure 10 Convergence curves for IEEE 39-bus System

Comparatively, the developed scheme not only provides superior cost reductions but also demonstrates faster

convergence than the other algorithms, as shown by the convergence curves for 100 iterations in Figure 10.

The superior performance of the CSA is as a result of the careful selection of the number of iterations and the parameters s, θ , μ and β as summarized in Table 7.

E. Developed ED Scheme on NPS

To establish its effectiveness on real-life system, the developed CSA-based ED is implemented on 52-bus Nigerian Power System (NPS) partitioned into three CAs with 8 GENCOs. Area A of the system has two GENCOS (G_1 and G_2), while B and C have three GENCOS each, (G_3 , G_4 and G_5) and (G_6 , G_7 and G_8) respectively, based on the data obtained from [42].

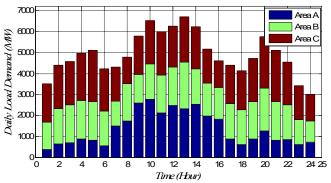


Figure 11 Daily Load demand for NPS

The system is loaded with 24-hour load profile shown in Figure 11. The load demand profile has daily averages of 1347.1MW, 1650.2 and 1931.0MW for the areas A, B and C respectively, as shown in Table 8

As in the previous scenario, the APF were assigned to define the contractual obligations between the areas, with values of 0.20, 0.45, and 0.35 for Areas A, B, and C, respectively. These factors dictate the ratio of generation across the areas, which is maintained at 0.2:0.45:0.35 (4:9:7). For example, at 01:00 AM, the generation capacities are distributed as 700 MW, 1575 MW, and 1225 MW for Areas A, B, and C, respectively.

From the results, it is observed that the developed CSA-based ED determined the optimal generations by assigning optimal λ to each GENCOS.

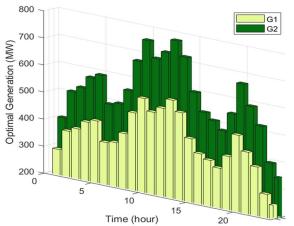


Figure 12 Optimal Participation of GENOS in area A of NPS

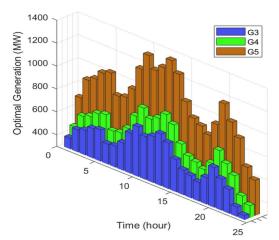


Figure 13 Optimal Participation of area B GENOs in NPS

Figure 12 shows the optimal generation from the GENCOS in area A. It shows how the 20% of the total generation allocated to area A is optimally shared by the developed ED among the GENCOS. As summarized in Table 9, the two GENCOS, G_1 and G_2 in area A optimally generated power in the ratio of 0.084:0.1160 to meet up with the 20% generation

share. This similar to area B with the optimal participations shown in Figure 13.

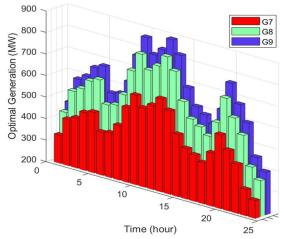


Figure 14 Optimal Participation of GENOS in area C of NPS

Likewise, the optimal λ of the area C are 0.0945, 0.133 and 0.1225 for G6, G7 and G8 respectively, which optimally add to the 35% of the generation share, as shown in Figure 14.

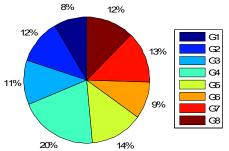


Figure 15 Overall Optimal generation share for the NPS

For instance, at 17:00 hour, 1540 MW (representing 35% of the total hourly demand of 4400 MW) is contracted to area C from DISCOs within and outside the area. The developed ED optimally allocated the generation levels as 415.8 MW, 585.2 MW and 539 MW to G_6 , G_7 and G_8 respectively, to meet up with the 1540MW at reduced fuel cost, without violating any the constraints. With these optimal allocations from the developed ED, the overall generation shares from all the 8 GENCOS are as shown in Figure 15.

To demonstrate the superior performance of the developed scheme, the generation cost is compared with those obtained using other various techniques, as summarized in Table 10. From the simulations, it is observed that the fuel costs for GENCOs in area A, B and C are found to be 6.346×10^5 \$/hr, 6.922×10^5 \$/h and 5.961×10^5 \$/hr, adding to up 1.923×10^6 \$/hr, as summarized in Table 10.

Among the techniques used for the comparative analysis, Bat Algorithm obtained the minimal cost of 2.185×10^6 \$/hr, yet not as effective as the developed CSA scheme which obtained the cost of 1.923×10^6 \$/hr, representing 12% reduction.

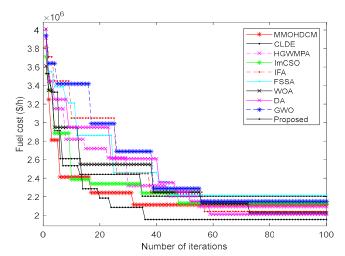


Figure 16 Convergence curves for NPS

As shown in Figure 16, which presents the convergence curves over 100 iterations, the developed scheme not only delivers greater cost reductions but also converges more rapidly than other algorithms. This demonstrates a significant advantage in both efficiency and computational time. The enhanced performance of the CSA is attributed to the careful tuning of the CSA parameters; s, θ , μ , and β , summarized in Table 11.

The fuel cost reduction achieved using the developed scheme is largely due to the imposition of the DPM constraint and the use of the CSA. The DPM captures discrete choices made by various market participants (GENCOs and DISCOs), offering a more accurate representation of the market participation. In addition, due to the CSA's ability to strike balance exploration and exploitation in the search space, it efficiently explores the solution space to find optimal solutions.

VI. CONCLUSION

In conclusion, the study developed an optimal scheduling of thermal generators in Multi-Area Power Systems (MAPS), while leveraging the significance of bilateral contracts between DISCOs and GENCOs within or across control areas modelled using DPM. Existing scheduling approaches often overlook these contracts, leading to suboptimal solutions and inefficient resource utilization. To address this, a DPM-constrained optimal scheduling scheme is developed, integrating a matrix capturing each GENCO's participation factors and contractual obligations with DISCOs. This scheduling scheme minimizes fuel costs of thermal generators, incorporating DPM, generation-demand balance, generation limits. transmission line capacities as constraints. The cuckoo search algorithm is employed due to its rapid convergence, adaptability, and global optimization capabilities to solve this DPM-constrained Economic Dispatch (ED) problem. Implementing this scheme on IEEE 39-bus and 52-bus Nigeria Power System (NPS) partitions into three control areas with multiple DISCOs and GENCOs shows significant fuel cost reductions. Compared to Grey Wolf Optimizer (MOGWO) and Bat Algorithm (BA) solutions, the CSA-based ED showcases

notable improvements—reducing fuel costs by 22.34% for IEEE 39-bus and 20.85% for the NPS. This demonstrated the significance of incorporating the DPM among the constraints and the CSA's superior optimization capabilities in achieving substantial cost savings for the power systems. For future research, dynamic ED problem can be considered for accuracy improvement, instead of static on hourly basis. This will ensure that the optimal generation schedules is computed while considering the changes of parameters such as load demand, generator costs, and system configuration over time.
